

ICPE – RECYCLE Olympiad - 2024

The Indian Centre for Plastics in the Environment (ICPE), a non-profit organization, is pleased to invite you to participate in its latest initiative for students, the 'ICPE - RECYCLE - Olympiad 2024.' This examination serves a dual purpose: to assess students' knowledge about the environment and to enhance their understanding of issues related to the recyclability and sustainability of plastics.

The Olympiad is open to students from Std. IV to XII and is divided into three categories:

Category-1: Class IV - VII

Category-2: Class VIII - X

Category-3: Class XI – XII

The questions will focus on thematic issues related to plastics recycling and sustainable development. The ICPE - RECYCLE - Olympiad will be held offline on October 5, 2024 from 10:00am – 11:00am. Schools must arrange to conduct exams in their classrooms.

All participating students will receive certificates in various categories, and their coordinating teachers of winning students will be acknowledged for their valuable contribution.

FAQ

1. What is Recycle Olympiad?

RECYCLE Olympiad is India's first annual examination on environmental issues related to Plastics & Recycling for school students. The examination is designed innovatively to test the knowledge of students and to educate and sensitize them in the process. One of its kind in India, the RECYCLE Olympiad asks questions on Plastics Recycling & sustainability. It is an annual MCQ-based examination.

2. What is the eligibility to participate in RECYCLE Olympiad?

Students of grades IV – XII enrolled in a school affiliated to recognized educational board or trust are eligible to appear for ICPE - RECYCLE Olympiad. Private coaching institute and similar entities are not allowed to participate in this exam.

3. How can one register for RECYCLE Olympiad?

ICPE - RECYCLE Olympiad will only accept school-based registration. Schools can register online through our website – www.icpe.in. On receiving your registration, ICPE will generate School code and send it through the email address provided in the registration. After that the school has to upload the names, classes of the students in the excel sheet along with School code.

4. What is the Syllabus/ Textbooks for RECYCLE Olympiad?

ICPE - RECYCLE Olympiad addresses a range of topics such as Plastics, Recycling, Sustainability. The examination is not based on any prescribed syllabus or textbooks. We encourage the participants to do extensive reading and be well versed with topics related to Plastics & Recycling. 5. What is the mode of examination?

Paper Based (Offline)

6. When is the ICPE RECYCLE Olympiad examination held in 2024?

Schedule (registration and examination) is as follows:

Commencement of Registration: April 2024

Last Date for Registration: July 31, 2024

Date of Examination: 05th October 2024, 10:00 am – 11:00 am

7. What will be the duration of examination?

60 minutes / 1 Hr.

8. How many questions will be there?

50 questions

9. If I have already appeared in the ICPE - RECYCLE Olympiad, can I register again?

If you fall under the eligibility criteria, you may participate in the RECYCLE Olympiad.

10. I am not an Indian citizen, nor do I reside in India, am I eligible for ICPE - RECYCLE Olympiad?

NO, you are not eligible for ICPE - RECYCLE Olympiad.

11. What is the registration fee for ICPE - RECYCLE Olympiad?

Schools must register their participation through the provided link on home page. The registration deadline is 31st July 2024. The school can charge INR 120 Per student as a fee for the exam. However, the school can retain INR 20 per student for conducting the exam in their premises. A registration fee of INR 100 per student is required, to be deposited in ICPE's bank account through NEFT/RTGS/Online Transfer.

12. How can we make payments?

For ICPE - RECYCLE Olympiad, schools can remit the total fee by payment gateway method during registration or through a Bank Draft drawn in favour of Indian Centre for Plastics in the Environment, payable at Mumbai (offline registration). For online transfer the details are as follows.

13. What will be the centre for examination?

ICPE - RECYCLE Olympiad: School will be the centre for its registered students. ICPE Secretariat will send question papers and OMR sheet before the examination.

14. Can we change the examination date after registration?

No, you cannot change the date of examination under any circumstances.

15. What should I do if I have forgotten my school code?

Please check back date e-mails from ICPE Secretariat else write an email to us to generate a new code.

16. Will we receive any certificates?

All participants and coordinating teacher will receive certificates. Merit and distinction certificates will also be awarded based on scores.

17. Are there any other incentives?

Certificates for all participants in distinction, merit, and participation category. Certificates for coordinating teachers. Prizes for Global Rank Holders. Invitation to attend ICPE' s environment and sustainability-related events. Opportunity to participate in capacity - building workshops on environment themes.
